- Waiver of Claims / Release of Liability.** Participant and Parent/Guardian acknowledge that the sport of football and skill development training for football are inherently dangerous activities involving physical contact, and Participant's participation in the Elliott Quarterback Academy is completely voluntary. Participant and Parent/Guardian hereby agree to waive, indemnify, hold harmless, and defend EQA, LLC and the school and/or location at which EQA provides its services, and their respective employees, agents, officers, staff and volunteers (collectively and individually, "The Academy"), from any and all claims arising out of Participant's participation in the Elliott Quarterback Academy, whether resulting from physical, mental, or emotional injury, loss, or property damage (collectively, "Injuries"). Participant and Parent/Guardian further acknowledge that EQA, LLC and the school and/or location at which EQA provides its services, and their respective employees, agents, officers, staff and volunteers are intended third party beneficiaries of this Waiver and Release. Participant and Parent/Guardian further agree that in no event shall The Academy be liable to Participant or Parent/Guardian for any Injuries suffered in connection with participation in the Elliott Quarterback Academy. Participant and Parent/Guardian further acknowledge that this Waiver and Release shall be construed broadly to provide a waiver and release to the maximum extent permissible under applicable law. Participant and Parent/Guardian further acknowledge that the scope of this Waiver and Release includes Participant's travel to, from, and during the Elliott Quarterback Academy.
- Equipment.** Participant and Parent/Guardian hereby acknowledge that The Academy will provide equipment to Participant to use in conjunction with the Elliott Quarterback Academy. Participant and Parent/Guardian acknowledge that he/she/they may provide his/her own equipment, which may be inspected, tested, sized, etc. by a third party at Participant's own expense.
